

# Still No Decision on Fair Funding for 2015

Spring has arrived and with it, I would like to provide you with an update.

At this time, there is no change in funding decisions for your 2015 fairs. Without an FY 16 budget, funding is unknown. Likewise, funding for your upcoming fairs in 2016 is also unknown.

With that said, your Fiscal Year 2017 (July 1, 2016 – June 30, 2017) Premium & Rehabilitation contracts are being held. As soon as we're given permission, we'll send them out to you via email and post them on our website. Please be advised that this may require a quick turnaround time.

The 2016 County Fair date listing continues to be updated on a weekly basis. The most up-to-date version is on our website; always check there for the most current information.

Horse racing at county fairs - There were only 174 nominations to the county fair racing circuit. This is 48% of what we received last year and unfortunately, implies that there will be a shortage of Illinois Conceived and Foaled (ICF) horses for your races.

The Bureau of County Fairs & Horse Racing, with the advice of the Standardbred Advisory Board, is providing several suggestions to assist you in filling your race cards

this summer. While these suggestions can be found on our standard-bred website, please work with your Colt Association representative, or call our office with questions.

Most importantly, let's remember the reason we do what we do: County fairs are at the root of developing future generations of Illinois citizens who will become actively involved in Illinois' agriculture industry.

### **Nominate Your Booster**

Does your fair have a dedicated volunteer or a community person who is a true county fair booster?

The "Friends of Illinois County Fairs" awards program will honor a group of recipients at the 107th Annual IAFE convention to be held next January. Your fair may nominate an individual to be recognized at the 2017 IAAF Convention. A nominee must be a supporter in some manner of Illinois County Fairs. They need not be an officer, a board member or a superintendent of a fair. However, they must be dedicated to the support, promotion, and innovative operation of a fair or fairs. This is a way to recognize the unsung stars of county fairs.

All Illinois fairs should consider nominating a candidate. The nomination form will be included in the summer IAAF packet mailed to each fair near the end of May. The forms may also be found on line at www.illinoiscountyfairs.org.

The committee uses the information to determine eligibility and for press releases. All entries must be submitted by September 1st. A fair may submit more than one worthy candidate for consideration.

Only one person or entity from any fair may receive the award in 2017. Any unselected candidates will be reconsidered in 2018 without reapplying. The IAAF "Friend of County Fair Award" program is sponsored by Jeff Blomsness of North American Midway Entertainment.

Note: Please do not confuse this award with the "Illinois County Fair Person" award presented by the Illinois Department of Agriculture at the State Fair's County Fair Day. They are two different awards. Information for "The Illinois County Fair Person" award will come from the Bureau of County Fairs. All fairs should also consider nominating worthy individuals for this award.

# **IDOA Announces New Fair Leadership**

Agriculture Director Raymond Poe recently announced an organizational restructuring at the Illinois Department of Agriculture (IDOA).

The Division of Fairs & Promotional Services will now house the bureaus of Illinois State Fair, DuQuoin State Fair, Business Services, and County Fairs & Horse Racing.

Previously, these bureaus operated independent of each other. This restructured division will allow better communication between the four bureaus and increase collaboration as they work towards their similar goals.

"Combining these already existing bureaus together in one cohesive unit will enhance efficiencies for the state of Illinois," said Director Poe. "Now all fair related activities will be centered in one division, under the leadership of one manager. These bureaus are vital to the Department, and with good leadership these bureaus will thrive."

Director Poe named longtime IDOA employee, Kevin Gordon, as Division Manager of Fairs & Promotional Services. Gordon will oversee the management of all four bureaus. Gordon previously held the role of Illinois State Fair operations manager. He has worked alongside multiple fair managers and has been instrumental in the planning and execution of every Illinois State Fair since 2000.

Gordon's experience relating to the inner-workings of the fair, including his working relationship with vendors and agriculture commodity groups, will seamlessly

# enhance his ability to run both the Illinois State Fair and DuQuoin State Fair.

Director Poe named Shawn Mayernick to work alongside Gordon as Assistant State Fair Manager in Springfield. Mayernick is the former Director of Business Partnerships for the Prairie Capital Convention Center in Springfield.

Director Poe also named Tibretta Reiman, as the new Assistant Manager of the DuQuoin State Fair. Reiman is no stranger to special events or the DuQuoin State Fair.

She previously served as a member of the State Fair Advisory
Board, the DuQuoin State Fair Non-Fair Event Advisory Committee, and most recently as the Development
Director for Trails to Adventure
Regional Tourism Development.

## Legislative Update by Margaret Vaughn

On March 1st, IAAF topped off Ag Day at the Capitol with its Annual Legislative Reception which was held at Boone's Saloon.

There was a great turnout of legislators from both parties from all corners of the state.

#### NO BUDGET TALKS

The four legislative leaders and Governor have not met together to discuss the Budget since early December and the first 3 months of 2016 were heavily concentrated on primary elections with the Speaker of the House having a serious opponent for the primaries, who was also indirectly sup-

ported by the Governor and there were also several very expensive legislative races that the Governor's supporters were very heavily involved in.

The Governor is still holding out for his "Turn About Agenda" before he agrees to pass a budget or otherwise he wants the Legislature to give him executive authority to make cuts and raid funds without going through the General Assembly which they are not willing to do.

#### **Below is IAAF's watch list:**

HB 4990- Rep Tim Butler (R-Springfield) /SB 2903 Sen. Bill Brady (R-Bloomington) - State/DuQuoin Fairground Foundation

Legislation has been introduced in both the House and Senate to create the Illinois State Fairgrounds Foundation under the authority of the Department of Agriculture as a mechanism to take in private donations for the State and DuQuoin Fairgrounds. The legislation creates a Board appointed by the Governor and Legislative Leaders to oversee the Foundation. Provides that any project, including but not limited to improvement, maintenance, and construction of infrastructure, that is funded in whole or in part by the Founda-

tion shall be considered a public work as defined by the Prevailing Wage Act but that the Procurement Code does not apply to procurement expenditures by the Illinois State Fairgrounds Foundation when only private funds are used.

HB 5758 – Sponsored by Rep. Sara Feigenholtz (D-Chicago) – Bullhook ban for elephants

Amends the Illinois Endangered Species Protection Act. Provides that any person who houses, possesses, or is in direct contact with an elephant shall not use a bullhook, ankus, baseball bat, axe handle, pitchfork, or similar device designed to inflict pain for the purpose of training or controlling the behavior of an elephant or permit an employee, agent, or contractor to use a bullhook, ankus, baseball bat, axe handle, pitchfork, or similar device designed to inflict pain for the purpose of training or controlling the behavior of an elephant. Provides that any person who violates this provision shall be subject to a civil penalty of not less than \$500 nor more than \$10,000 for each violation, and shall be subject to permit revocation under the Act. Provides that the Department of Natural Resources may adopt rules to enforce this prohibition.
